Data Protection

1. CONTROLLER IDENTIFICATION AND CONTACT DETAILS

- 1.1. The controller of your personal data is Jan Jelínek, Honech I 5537, 760 05 Zlín, Czech Republic identification number 65360559, registered in the Trade Register maintained by the municipality of Zlín (hereinafter referred to as "Controller").

- 1.3. The administrator did not appoint a Data Protection Officer.

2. LEGAL GROUNDS FOR LAWFUL PROCESSING OF PERSONAL DATA

- 2.1. Hereinafter referred to as Controller processes in accordance with Regulation (EU) No. 2016/679 of the European Parliament and of the Council on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46 / EC (General Data Protection Regulation) (hereinafter "the Regulation"), the following personal data:
 - name surname
 - address / registered office
 - e-mail address
 - telephone number
- 2.2. The above personal data must be processed for the processing of orders and further performance of the contract, if a purchase contract is concluded between you and the seller. Such processing of personal data is permitted by Article 6 (1) (a). b) Regulation - processing is necessary to fulfill the contract. The seller also processes this data for the purpose of registration of the contract and possible future application and defense of the rights and obligations of the parties. Storage and processing of personal data is for the above purpose for 10 years from the last part of the contract, unless otherwise required by law contractual documentation for a longer period. Such processing is possible on the basis of Article 6 (1) (a). c) and f) Regulation - processing is necessary to fulfill the legal obligation and for the purposes of the legitimate interests of the controller.
- 2.3. News and other business communications may be sent to the buyer at the e-mail address or telephone number, this procedure is enabled by Section 7, Paragraph 3 of Act No. 480/2004 Coll., On Information Society Services, unless the buyer rejects it. These communications can be unsubscribed at any time, for example by sending an email or clicking on a link in a business communication.

3. TIME OF STORAGE OF PERSONAL DATA

- 3.1. The period for which your personal information shall be stored by the Controller is 10 years (except for legal reasons), but no longer until your consent to the processing of personal data (for this purpose) is withdrawn.

4. OTHER RECIPIENTS OF PERSONAL DATA

- 4.1. Your personal data shall be disclosed to the following recipients. Bohemiasoft s.r.o. (server administrator), Unihost s.r.o. (server administrator) and Casablanca INT (Data Center Operator), General Logistics Systems Czech Republic s.r.o. (delivery company)

5. RIGHTS OF THE DATA SUBJECT

- 5.1. Under the terms and conditions set forth in the Regulation, you have the right to request from your administrator access, rectify or delete your personal data, or limit their processing, the right to object to the processing of your personal data, and the right to your personal data portability.
- 5.2. You have the right at any time to withdraw your consent to the processing of your personal data given to the Controller. However, this is without affecting the lawfulness of your personal data processing based on consent before its withdrawal. Your consent to processing your personal data can be withdrawn via email: **shop@jawaparts.com**
- 5.3. If you believe that the processing of your personal data or the Regulation has been violated, you have the right inter alia to lodge a complaint with a supervisory authority.
- 5.4. You are under no obligation to provide personal information. The provision of your personal data is a necessary requirement for the conclusion and performance of the contract and without providing your personal information, it is not possible to conclude the contract or to fulfill it by the trustee.

These terms come into effect on 24.5.2018
